We invite you to join us in presenting innovative workshops at the 35th annual Washington Behavioral Healthcare Conference!

The conference brings together a diverse group of presenters to share information about therapeutic interventions, recovery supports, promising programs, and policies that advance best practices. Our goal is to provide a learning experience that expands professional knowledge, promotes community partnerships, and helps make recovery a reality. We're interested in sessions that are practical, replicable, and relevant to our attendees. We anticipate over 650 attendees in Kennewick—this is a great opportunity to share your knowledge and experience, and inspire others!

As a presenter at the 2025 WBHC, you'll gain visibility and have the opportunity to interact with a broad audience. Conference attendees include clinical staff, program managers, people with lived experience, family members, peers, nonprofit staff, and staff of system partners and state agencies including the Health Care Authority, DSHS, and the Department of Corrections.

Each proposal chosen will receive a complimentary conference registration and one night hotel accommodations for each presenter (up to the limit of speakers as noted below). Travel expenses and per diem are not provided.

- ◆ Most workshops are scheduled for 90 minutes (limit of 3 speakers); this year we will also have a limited number of TED-style talks of 18 minutes each (limit of 1 speaker per Talk). Please tailor proposal materials and objectives to fit within one of these time frames.

2025 WBHC Presentation Application

Advancing the Future of Behavioral Health

Proposals will be evaluated according to the following criteria:

- ✓ Relevance to participants' interests, clear benefit to attendees' educational needs & skill development, and replicability in other treatment organizations
- ✓ Promotion of advanced clinical skills
- ✓ Clear articulation of the learning objectives, which must be measurable and achievable
- ✓ Experience and/or expertise of the presenter(s)
- ✓ Meaningful inclusion of people who identify as having lived experience
- ✓ Contribution to improved outcomes, recovery, and quality of life of those served
- ✓ Incorporation of evidence-based, best and/or promising practices
- ✓ Use of person-first language and sensitivity/applicability to a multicultural population

All proposals must be complete, comprehensive, and deemed relevant and timely to the conference's audience.

Presentations must be educational in nature and may not be used to market products or services. If chosen, we expect that your presentation in June will reflect the materials & objectives submitted.

To support our commitment to diversity, equity and inclusion, we are committed to creating WBHC programming that reflects the diversity of the communities we serve. Please consider including a diverse set of speakers when submitting your proposal.

There is a limit of 3 speakers per workshop, and a limit of 1 speaker for a TED-Style Talk. Completed applications MUST be submitted by 11:59 pm on December 6, 2023 and must include:

- Presentation title
- Focus Area
- Learning Objectives
- Abstract (approximately 300 words, for use in brochures if presentation is chosen)
- Intended Level/Audience of Presentation (general behavioral health or advanced clinical practice)

Required info for each presenter:

- First & Last Name
- Degree (incl. field of study)
- Preferred Pronouns (optional)
- Organization (if applicable)
- Street Address, including City, State & ZIP
- Phone & Email
- Biography of *each* presenter (including one credible reference regarding experience in presenting and/or facilitating workshops, seminars or presentations)

Please note that speakers must provide their own laptop.
